Each horse must have a **completed entry, signed release AND full payment** to be entered. We will make every effort to accommodate all entries.

Schooling draws to be posted online at www.wcrha.com by end of day January 30, 2019.

Schooling times run from 7:00 AM to 7:00 PM with 1 hour from 12:00 pm to 1:00 pm for fencing and circling.
Open Arena Wednesday until 6:00 pm, Thursday until 7:00 pm, Friday & Saturday for 1 hour after schooling.

Schooling Slots are 6 **minutes each** (1 minute to enter, 4 minutes to school, 1 minute to finish and exit arena)

Cost: \$35 per schooling run/per day.

Stalls: \$130 for all three days - you may arrive at 12:00 pm on Wednesday January 30, 2019, (no earlier please!)

Haul In Fee: \$25 per day (if you do not have a stall) **Trainers:** Need tack stall count & check before schooling begins.
