Committee has agreed to add a tier of sponsorship level and change the dollar amounts in a few levels.

Buckle/Bronze/ Silver remain at prior dollar levels.

Gold/Platinum and new Diamond levels have changed.

Barbi to update sponsorship package to put on website.

Kain is working with Lavoy on logos to be added to live and delayed feeds.

Megan is working on developing a cadence of announcing sponsors at each level and a use a templated creative for publishing new sponsors as they come in.

Jaimin is working on thank you cards to go out as sponsors come in and with Elizabeth on a corporate donation matching program that Elizabeth is familiar with.

Barbi suggests a fundraiser for Affiiate#3 that help bring in monies to support the event we are looking to produce with more added money in some classes.

She recommends WCRHA VIP tables sold at \$1K a piece. VIP tables will be set up similar to how larger "events" promote VIP experiences such as:

Seated, rail level at arena viewing.

Table side refreshments

Flowers and table clothes

Table to sit 8

Barbi will work with her contact Nick to arrange table/chairs/table clothes to be set up

Goal is to sell 9-10 tables.

Committee to come back to BoD with cost and full development of this fundraiser at a future date. Tent and tables except for rental of table clothes will be sponsored by Barbi (Nick) contact – sell table for \$1K.

Show Committee

Kelli reports Affiliate #2 forms are close to being completed. She will send to Melinda for posting by the weekend.

Affiliate #3 will be named "Star Spangled Slide at Woodside."

Rookie Shoot Out requirements are being worked on.

Saddle has been ordered for the class through Equine Oasis.

Show Committee is looking to include additional added monies in the following classes:

Open, Non Pro, NHOL2 and NHNOL2

Open Derby L1,L4, NP Derby L1,L4, NHO Derby L4 and NONP Derby L4

Agreement on amounts need to be confirmed by end of month (March)

Kelli will send out to BoD in email detailed cost vs added monies for consideration.
